



“Urban Conflicts and Peace: Everyday Politics of Commons”

The International Conference of the AESOP Thematic Group “Public Spaces and Urban Cultures” (TG PSUC), 5 - 6 October 2023, Naples, Italy, organized by the National Research Council of Italy, Institute for Research on Innovation and Services for Development (CNR-IRISS, Italy), together with the BTU Cottbus-Senftenberg (Germany), and University of Florence – LAPEI (Italy), which was hosted by the University Federico II of Naples, Department of Architecture (Italy).

The conference is part of the series of events to the working theme 2022-2024 of the AESOP Thematic Group Public Spaces and Urban Cultures (TG PSUC; <https://aesop-planning.eu/resources/news-archive/thematic-groups/public-spaces-and-urban-cultures>) titled “Public Spaces, Urban Cultures and Constructing Peace” (<https://aesop-planning.eu/resources/news-archive/thematic-groups/public-spaces-and-urban-cultures/aesop-tg-psuc-representatives-of-forthcoming-events-2021-2023>).

Introduction

Urban space and everyday life are permeated with conflicts across multiple scales: from struggles with political oppression, health, ecological and economic crises that are often dictated by the competition for geopolitical influence, over struggles to the right to social and cultural difference, to often invisible struggles and violence that permeate spaces of homes. Against these fragmentation tendencies, the commons glue social fabric together, urging societies to aim for peace. While the construction of peace has a transformative power in shaping shared urban futures, it also carries possible negative dimensions in the form of preservation or reproduction of disparities in power relations, be it at the level of global peacemaking or at the level of the home. It is through the engagement with the politics of commons and their production in everyday life that the construction of peace can be understood as an everyday operation of negotiation across a broad spectrum of differences that aims at instilling a sense of harmony within shared space and time. Commons display how peace is constructed, how societies arrive at peace in everyday life, and how urban space mold the understanding of what kind of peace societies aim to arrive at.

Theme

The conference reflects on the politics of commons as inherently bound to the ways and means of how urban societies negotiate between urban conflicts and peace. The goal was to conceptualize the relationship between conflict and peace beyond their usual perception as a binary pair. For peace can maintain imbalances in power relations which might violently affect parts of urban population, as much as urban conflicts might open up the opportunity for more democratic participation and the recognition

of differences. In the realm of politics, conflicts may shape a transformative public sphere which contests the given unjust conditions and renegotiates meanings and actions.

The commons display how societies have contested, innovated, produced and governed differently – they are integral part of an everyday construction of urban peace in which power relations are continuously rebalanced. They allow for a profound insight into assemblages of institutional and social actors and their daily interactions unfolding in the range of practices and settings, from the micro level of informal improvised tactics to the structured institutionalized settings of urban politics. At the same time, they extend the field of exploration to settlements, services and organizations that do not fully fit into the institutionally demarcated framework of city-making and which can build the city in a different way. To grasp these transformative moments of agency and to understand contentious acts of publics as political, this conference aims to interpret commons through various epistemologies, theories and practices, including but not limited to those from the Global South or from the feminist perspective on the city.

Programme

A 2-day conference including keynote lectures, paper presentations, a fieldtrip-workshop in Bagnoli neighborhood visiting the National Interest Site “Bagnoli-Coroglio” and meeting the main actors participating to the regeneration and remediation process, and then visiting the Lido Pola – Common and its community.

Keynotes



Stavros Stavrides, architect, and activist is Professor at the School of Architecture, National Technical University of Athens, Greece, where he teaches graduate courses on housing design (social housing included) and urban design, as well as a postgraduate course on the meaning of metropolitan experience. He is currently the head of NTUA Lab for the Architectural Design and Communication. He has done extensive research fieldwork in Brazil, Uruguay, Argentina, Colombia, Venezuela and Mexico focused on housing-as-commons and on urban struggles for self-management. His recent publications include *Housing as Commons* (edited with Penny Travlou, London 2023), *Common Spaces of Urban Emancipation* (Manchester 2019), *Common Space. The City as Commons* (London 2016, Istanbul 2016, Athens 2019, Lisbon 2021, Milano 2022, forthcoming in Bucharest, Belgrade and Seoul), *Towards the City of Thresholds* (Trento, 2010, Madrid 2016, Istanbul 2016, N. York 2019),

Suspended Spaces of Alterity (Athens, 2010) and From the City-as-Screen to the City-as-Stage (Athens, 2002 National Book Award) as well as numerous articles on spatial theory and the urban commoning culture. He has lectured in European and North and South American Universities on urban struggles and practices of urban commoning.

Commoning power in a city of thresholds

Emergent urban communities may reinvent commoning as a practice of sharing based on relations of equality and mutual support. This is a multileveled and often contradictory process through which new forms of social organization emerge. Urban commoning acquires an emancipatory potentiality when it challenges the everyday routines of social reproduction. Either by permeating everyday life or by creatively interrupting it during urban struggles, commoning may gesture towards a just peaceful coexistence only if it develops forms of sharing power, forms of commoning power. Common spaces produced by the development of new urban habits and rituals are to be understood not as temporary enclaves of otherness but as thresholds which communicate and multiply. By using concrete examples from Europe and Latin America this presentation will try to show that explicit and implicit efforts for collective emancipation may construct cities of commoning as emerging cities of thresholds.



Maria Anita Palumbo, is an anthropologist, she holds a PhD in social anthropology from EHESS-Paris (2014). She is Associate Professor (Tenure) in Human and Social Sciences (since 2015), faculty member of the Lille School of Architecture and Landscape where she joined the interdisciplinary research department LACTH. Her research, teaching programs and publications focus on the link between anthropology and architecture, the processes of urban transformation of peripheral and disadvantaged neighborhoods, collective housing transformations by inhabitants, alternative and political way of dwell in European cities, public spaces and urban-domestic boundaries critical thinking,

ethnographic methods for urban designers and architects. Her recent publications include: «L'entre-deux-barres. An ethnography of the transformation of collective housing complexes by their inhabitants» Sainte-Etienne, PUSE, 2023, p.700, the co-authored with architect Olivier Boucheron. Since 2017 she lives in Bruxelles and collaborates with *mama.brussel*, an architectural practice that put at the center of its work the claiming of maintenance as a fundamental act of architecture.

Beyond war and peace: few words on the diplomatic power of commoning

Starting from situations observed in several cities at an international scale, we will attempt a political reading of actions in/on public spaces revealing processes of negotiation aiming at establishing a better cohabitation with others, with nature, with the built environment. Through a situated knowledge gained during ethnographic fieldwork we will question contemporary dwelling and the production of the city reaffirming the importance of a materialistic turn in our urban analysis: indeed materiality embodies past, present and future social projects that might not be so peaceful, nor so stable, after all and any direct interaction with it can be perceived as a political diversion...Beyond situations of war and global peace ambitions, we will address the reintroduction of conflicts (and their reparations...) as ingredients of social life; discuss the ethnographic evidences of public/private realm dichotomy irrelevance; consider

the political need for enlarging the spectrum of legitimate actors producing, maintaining and transforming spaces; propose to push our theoretical frame beyond classical binary categories by considering dwelling as a technique, domesticity as an ecosystem, commoning as a sets of diplomatic competences.
