9:45 - 11:00 Session 1: The professional recognition of the planning profession, a state of the art

The 2nd meeting of AESOP Heads of Schools in Leuven (2007) opened the debate on the possibility of developing a professional recognition for the planning profession through a European regulation (“professional platform”). To achieve such a recognition, a strong mobilization, together with the representatives of practitioners, is necessary. A first step is to assess the criteria of recognition in European member states. Our meeting aims to analyze pros and cons of being a regulated profession. The keynotes will provide an analysis building upon the cases of countries where planning is regulated – or not and will be followed by a debate.

- **Planning as a regulated profession (Turkey):** in Turkey, planning is a regulated profession and the country has created a Chamber of Planners, separate from the Chamber of Architects. Benefits and limits of the situation will be presented by Zeynep Enlil in representation of the Turkish Association of Schools of Planning.
- **Planning as a non-regulated profession (Sweden):** in Sweden, as in many other European countries, there is no regulation of the Planning profession. Pros and cons will be presented by Kristina Nilsson, Univ. of Lulea, Vice-President of AESOP
- **Planning as a self-organized profession (UK):** Many believe that in the UK planning is a regulated profession; actually, it is not regulated by law. However, in practice, the individual accreditation granted by the RTPI is almost necessary to find a job as a consultant. By Andrea Frank, University of Cardiff
- **The point of view of the European Council of Spatial Planners:** a European Platform for Recognition of Professional Qualifications and Education by Henk van der Kamp, Irish Planning Institute
- **Debate** moderated by Maros Finka, TU Bratislava, AESOP quality officer.
